Application for the Review of a Premises Licence under the Licensing Act 2003 –

Premises Licence Number 4251:-Victoria Vibes, 48 Market Place, Henley RG9 2AG

Recommendation(s)

- 1. That the Panel consider the application for review of this licence, and
- 2. Having heard all the evidence submitted by the various parties at the hearing, taken into account the Secretary of State's Guidance issued under Section 182 Licensing Act 2003, and the council's Statement of Licensing Policy determine if based on this that any or all of the licensing objectives have been undermined, and
- 3. If the Panel conclude that any or all of the licensing objectives have been undermined then they are recommended to consider what measures are necessary and proportionate in order to ensure that those licensing objectives are promoted.

Purpose of Report

1. To present the facts and relevant representations received in respect of an application by Thames Valley Police, for a review of the premises licence for Victoria Vibes, 48 Market Place Henley RG9 2AG, under Section 51 of the Licensing Act 2003 to the Licensing Acts Panel in order that the Panel can determine the application.

Strategic Objectives

2. The relevant objectives are those of "helping people to feel safe and secure" and "managing our business effectively". The relevant corporate priorities are those of "provide value for money services that meet the needs of our residents and service users" and "maintain low levels of fear of crime and anti-social behaviour".

Background

3.1 The Licensing Act 2003 ('the Act') has established a single integrated scheme for licensing premises which are used for the supply of alcohol, regulated entertainment, late night refreshment or permission to carry on some or all of these activities. In the Act these activities are referred to collectively as the 'licensable activities'.

Any assessment of licensable activities must consider and promote the following four statutory objectives:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance and
- The prevention of children from harm
- 3.2 When a valid application is received for the review of a premises licence and the review has not been withdrawn the matter will be referred to a Licensing Acts Panel to determine the application.
- 3.3 An application was received from Thames Valley Police on 15 August 2011 under Section 51 of the Licensing Act 2003 for a review of the Premises Licence **No. 4251** in respect of Victoria Vibes, 48 Market Place, Henley on Thames, RG9 2AG.

The grounds for the review are:-

Thames Valley Police are calling for review of this licence due to the premise breaching conditions and not upholding the crime and disorder and prevention of public nuisance objectives of the 2003 Licensing Act.

There are concerns over the regular breaches of licence and the attitude of the Designated premises supervisor and Premise Licence Holder. There have been instances of public order towards police by Mr Vanni. The premise has also had high drugs results and has failed to implement suggested interventions resulting in an increase in results.

The majority of complaints and incidents have occurred after 23.00.

A copy of the review application together with the supporting documentation from Thames Valley Police is attached at **Appendix 1**.

South Oxfordshire District Council as the licensing authority were responsible for placing the necessary signs on the premises and these were put up on Tuesday 16 August 2011 inviting comments on the review application by 13 September 2011. A copy of the "blue notice" is attached at **Appendix 2**. There have been a number of instances of the "blue notices" being removed by persons unknown but with the assistance of the police in Henley these have been replaced as necessary. The review has been called for in respect of the crime and disorder and prevention of public nuisance licensing objectives. Thames Valley Police confirmed that copies of the review documentation were also served on the responsible authorities and premises licence holder.

- 3.4 A copy of the current Premises Licence 4251 is attached at Appendix 3 for information. This licence was first granted on 24 November 2005 to the current premises licence holder and is the licence that is currently in force. The Designated Premises Supervisor (DPS) is Mr Christiano Vanni, who holds a Personal Licence issued by Oxford City Council, PL/279 and he has been the DPS since the licence was issued.
- 3.5 Health and Safety and Planning in their capacity as Responsible Authorities have raised no comments on the review process either in support of it or against it.
- 3.6 Environmental Protection in their capacity as a Responsible Authority has commented on the review and their letter of representation is attached at **Appendix 4**.
- 3.7 Ten letters of representation were received; eight in support of the review process and two in support of the premises and these are attached as **Appendices 5-14**. The issues raised in the letters are of relevance to the review and have come from persons or businesses within the vicinity of the premises. A number of other letters were received but have been rejected because they either came from persons outside of the vicinity of the premises, or did not give either a name or address or raised issues that were not relevant to the review.

4. Options

- 4.1 In determining an application for the review of a premises licence the authority must give weight to:
 - Representations received from Responsible Authorities
 - The Secretary of State's Guidance Issued under Section 182 of the Licensing Act 2003
 - The Statement of Licensing Policy
 - The steps necessary to promote the Licensing Objectives

- 4.2 The Panel are reminded that any decision they consider has to be proportional to only do that which it considers necessary to promote those licensing objectives that may be considered to have been undermined.
- 4.3 In view of the above, the Panel is requested to consider the application for a review of the premises licence and decide whether:
 - Take no action, or
 - Issue a warning to the premises licence holder, or
 - Suspend the licence for a period not exceeding 3 months, or
 - Revoke the licence, or
 - Remove the DPS, and/or
 - Vary the licence by removing, some or all of the licensable activities, and/or
 - Vary the licence by amending the hours the premises can be open, and/or
 - Vary the licence by amending the hours during which any of the licensable activities can be provided, and/or
 - Vary the licence by attaching additional conditions to the licence

5. Financial Implications

5.1 Should the applicant or any party aggrieved by the decision wish to appeal against the decision of the council; they may do so to the Magistrates' Court. The council would incur costs should this occur, although the court may decide to award costs if the council's decision is upheld.

6. Legal Implications

- 6.1 The Human Rights Act 1998 requires public bodies to ensure everything they do is compatible with Convention Rights and makes it unlawful for a public authority to act incompatibly with those Rights. When determining applications for the review of an existing licence the panel will be aware of Human Rights considerations, specifically Part 1, Article 6, right to a fair trial and Part 2, Article 1, peaceful enjoyment of possessions (a licence is deemed to be a possession).
- 6.2 The hearing of all applications is subject to the principles of natural justice.
- 6.3 Section 17 of the Crime and Disorder Act 1998 states, 'without prejudice to any other obligation imposed on it, it shall be the duty of each authority to exercise its various functions with due regard to the likely effect of those functions and the need to do all that it reasonably can to prevent crime and disorder in its area.'
- 6.4 Under Schedule 5 part 1 of the Licensing Act 2003 any person aggrieved by the decision in respect of the review application may appeal to a Magistrates' Court within 21 days of the date of the decision.

Conclusion

- 8.1 This report provides information submitted by the applicant for the review, Environmental Protection and other interested parties. The panel should determine this application with a view to promoting the relevant Licensing Objectives which are 'the prevention of crime and disorder' and 'the prevention of public nuisance' and have regard to the relevant provisions of the Act, Guidance and Policy.
- 8.2 The Panel should, having heard all the evidence submitted by the various parties at the hearing, taken into account the Secretary of State's Guidance issued under Section 182 Licensing Act 2003, and the council's Statement of Licensing Policy determine if based on this that any or all of the licensing objectives have been undermined.
- 8.3 If the Panel conclude that any or all of the licensing objectives have been undermined then they should consider what measures are necessary and proportionate in order to ensure that those licensing objectives are promoted. The options available for the panel to consider are set out at paragraph 4.3 above.

The local Sergeant and Inspector as well as the licensing department have had many meetings with the premise in order to advise the premise of our concerns but the problems still persist.

The meeting held on the 3rd Feb 2010 was held to discuss the conduct of the management, underage sales, drugs, disorder and noise. It was stated at this meeting that this was a final warning and that further incidents would result in the premise being taken to review. See Annex 2 for full letter.

On the 11th June 2011 an incident occurred relating to the DPS of the premise where by he received 2 cautions for public order and drug possession. See annex 5 for more info.

Thames Valley Police have concerns that the premise is unable to run and manage its customers in accordance with its premise licence as a late night drinking venue. This is shown by the number of incidents occurring after 23.00 please see below.

On the 12th August 2011 a full licensing check was conducted by myself and PC Finnis at the Victoria PH in Henley-on-Thames.

Upon this check the following conditions were breached:

Annex 1 Mandatory conditions

6.

- 1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- 2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

No policy could be provided

Annex 2 – conditions consistent with operating schedule

- All staff involved in the service of alcohol will be trained in relation to the law regulating the supply of alcohol and the conditions of this licence prior to commencing their duties and at 6 monthly intervals thereafter.
- A log will be kept of all staff training, such records to be retained for at least 12 months. The record will be available upon reasonable notice to the Police and/or the licensing authority.
- There will be CCTV in operation to enable staff at the bar to observe areas not directly visible from the bar.
- 7 There will be a Proof of Age policy in force in the premises, to the satisfaction of the Police and the Licensing Authority.

No staff training available to be viewed, no CCTV has ever been in operation at the premise, no age policy in place as with Annex 1.

Annex 3 – Conditions attached after a hearing by the licensing authority

The premises shall comply with the operating schedule as set out in the application.

As above not met.

Also noted as part of the check was a small table with 2 chairs outside the premise there is no chairs and table permit for this and it is on a public highway so this was pointed out and removed.

The licensing officer was met with some resistance on this check Mr Vanni was perceived as aggressive and rude stating that "police should have better things to do than the checks and that I should not be coming in at 19.30 to do this I should be coming at 10am in the morning so as not to disrupt business". Ms Townsend was on the other hand very helpful and stated that "she did not realise that these conditions were on the licence otherwise they would be complied with".

Suggestions put forward at meeting held 3rd Feb 2010

- Only accept passport or driving licence as forms of ID
- 1 drink per person to prevent of age people buying for underagers.
- Operate a think 21 policy.
- On Friday and Saturday nights no under age people are allowed in after 22.00.
- Keep a refusal book. Documenting all those who have been refused service due to no ID or under age.
- Signs on all exits stating that no glasses to be taken outside and to leave quietly and respect the neighbours.
- Regular checks on the outside for noise levels and people taking glasses out. (some form of documentation to state when this is being done)
- Drugs posters stating that drugs will not be tolerated on the premise.
- Regular toilet checks with documentation of when this is done.
- Open communication with the Local police team and address officers appropriately.

No age policy but had think 18 posters up. Intel of persons out side the premise with glasses. Attitude towards licensing officer on the 12th August check.

The above meeting was called in order to discuss concerns that have arisen at the premise and to come to an agreement to reduce and stop these issues from occurring further. At this meeting the following was discussed.

- Conduct of the management.
- Underage sales
- Drugs
- Disorder
- Noise

The following are suggestions in order to combat against the above.

- Only accept passport or driving licence as forms of ID
- 1 drink per person to prevent of age people buying for underagers.
- Operate a think 21 policy.
- On Friday and Saturday nights no under age people are allowed in after 22.00.
- Keep a refusal book. Documenting all those who have been refused service due to no ID or under age.
- Signs on all exits stating that no glasses to be taken outside and to leave quietly and respect the neighbours.
- Regular checks on the outside for noise levels and people taking glasses out. (some form of documentation to state when this is being done)
- Drugs posters stating that drugs will not be tolerated on the premise.
- Regular toilet checks with documentation of when this is done.
- Open communication with the Local police team and address officers appropriately.

It was also discussed at this meeting that due to the smoking ban some of the above issues could be addressed by extending the use of the garden till 23.59. This is a possibility from a Police point of view but due to the number and nature of issues that currently stand it would not be considered until some of the other issues have been addressed.

I must state that this letter has been issued as a final warning and that any further incidents of this nature will result in your premise being taken to review.

Annex 1 - Mandatory conditions

Supply of alcohol

- 1. No supply of alcohol may be made under the premises licence
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

3.

- 1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children
 - a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
 - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - II. drink as much alcohol as possible (whether within a time limit or otherwise);
 - b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
 - c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
 - d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
 - the outcome of a race, competition or other event or process, or
 - II. the likelihood of anything occurring or not occurring;
 - e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be

considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

- 4. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

6.

- 3) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- 4) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 7. The responsible person shall ensure that-
 - a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - I. beer or cider: ½ pint;
 - II. gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - III. still wine in a glass: 125 ml; and
 - b) customers are made aware of the availability of these measures.

Door supervision (where applicable)

- 1. All individuals at the premises to carry out a security activity must be licensed by the Security Industry Authority.
- 2. For the purposes of this section
 - a) "security activity" means an activity to which paragraph 2(1)(a) of The Private Security Industry Act 2001
 - b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 – Conditions consistent with Operating Schedule


1 The premises will be a member of the Pubwatch scheme for the local area. 2 A personal licence -holder will be on the premises whenever an event involving live and/or recorded music is taking place. 3 All staff involved in the service of alcohol will be trained in relation to the law regulating the supply of alcohol and the conditions of this licence prior to commencing their duties and at 6 monthly intervals thereafter. 4 A log will be kept of all staff training, such records to be retained for at least 12 months. The record will be available upon reasonable notice to the Police and/or the licensing authority. 5 There will be CCTV in operation to enable staff at the bar to observe areas not directly visible from the bar. 6 The duty manager will respond promptly to any reasonable complaint received regarding the conduct of the premises and will take appropriate action. 7 There will be a Proof of Age policy in force in the premises, to the satisfaction of the Police and the Licencing Authority. 8 Signs will be displayed regarding prohibition of sales to persons under 18 years of age or those purchasing on their behalf. 9 Signs will be displayed on or in the immediate vicinity of the AWP machines stating that no person under the age of 18 years old may play on the machine.


Annex 3 – Conditions attached after a hearing by the licensing authority

1	The Premises Licence is granted for the area shown on the plans submitted to the Licensing Officer.
2	The premises shall comply with the operating schedule as set out in the application.
3	There shall be no admissions or readmissions to the premises after midnight every day of the year.
4	Rear doors to the premises (as highlighted in red pen on the attached plan) must remain closed, other than for access or egress between

22:00 hours and 06:00 hours on any day.

- Prominent, clear notices shall be displayed at [all exits / in the beer garden] requesting that customers respect the needs of local residents and leave the premises and the area quietly.
- Outside areas must not be used by customers after 23:00 hours and before 06:00 hours on any day.
- 7 Entertainment is to be held internally only and no music or speakers shall be provided to external areas of the premises.
- Noise emanating from the premises as a result of regulated entertainment shall not be clearly audible within the premises known as 50 Market Place or at the boundary of any nearby residential premises.

Thank you for consulting this Service regarding the above application.

The current conditions are felt to be adequate to control noise emanating from the premises, and were recommended by the Environmental Protection Team at the time of the application for the Premises Licence.

The Environmental Protection Team has received many complaints relating to noise emanating from the premises. I have listed below a breakdown of the complaints received since 2006 and the outcome of each complaint

In most instances we sent out diary sheets to log the events and gather evidence of a statutory nuisance, we did not receive any diary sheets back from any complainants therefore we were unable to pursue these complainants further. We did respond to calls using our 'out of hours' noise service to visit complainants however the noise had subsided by the time we had arrived and we were unable to substantiate the complaints. We therefore have no direct evidence to confirm the noise complaints we received since 2006.

I visited the Victoria on 5 June 2009 with the previous licensing manager, Alistair Dearling and spoke with Mr Vanni and Ms Townsend on the importance of maintaining control of the premises with regard to noise and licensing objectives. However, after a few minutes when we gave examples of the problems that needed improvements on; such as patrons being noisy at the front of the premises and failing the underage drinking test, Ms Townsend became verbally abusive towards us and told us to leave, we therefore ended the meeting and left. Mr Vanni telephoned to apologise and asked to us to return, however we did not see any value in revisiting the premises as we had given the intended advice and discussed the elements that needed improving albeit briefly .

In response to the comment made by the police, which advises that the problems of smoking on the front may be alleviated by opening the back garden longer, the council has served a notice on previous tenants of the premises, in 2003 prohibiting use of the back garden after 23:00 due to unreasonable noise levels experienced by neighbouring properties. Therefore we would advise that this will not be a suitable

solution to the noise problem and that better control over the patrons of the premises in general is required.
