# PUBLIC PATH DIVERSION ORDER HIGHWAYS ACT 1980, SECTION 119 SOUTH OXFORDSHIRE DISTRICT COUNCIL WALLINGFORD FOOTPATH NO. 1 (PART) PUBLIC PATH DIVERSION ORDER 2007

This Order is made by South Oxfordshire District Council (the authority) under section 119 of the Highways Act 1980 because it appears to the authority that in the interests of the owner of the land crossed by the footpath and the public using the footpath it is expedient that the path is diverted.

Oxford University has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Oxfordshire County Council has been consulted as required by Section 120(2) of the Highways Act 1980.

BY THIS ORDER

- 1. The footpath over the land situated at Wallingford and shown by a bold blue line on the map contained in this Order and described in Part A of the Schedule to this Order shall be stopped up from the date on which Oxfordshire County Council certify that Article 2 of this Order has been complied with.
- 2. There shall be created to the reasonable satisfaction of Oxfordshire County Council an alternative footpath for use as a replacement for the said footpath as provided in Part B of the Schedule and shown by a bold red line on the map attached to this Order.
- 3. There shall from the date on which Oxfordshire County Council certify that Article 2 of this Order has been complied with be a public footpath over the land situated at Wallingford described in Part B of the Schedule and shown by a bold red line on the map contained in this Order.
- 4. Where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.
- 5. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part C of the Schedule.

#### PART A

#### Description of site of existing path

The entire width of that length of Wallingford Footpath 1 running from point A Grid Ref SU 60883 88842, in a westerly direction for 15m to point B Grid Ref SU 60867 88843 thence in a westerly and southerly direction for 13m to point C Grid Ref SU 60860 88836 and then in a south easterly direction for 39m to point D Grid Ref SU 60878 88801 continuing in a southerly direction for 42m to point E Grid Ref SU 60866 88761 as shown on the map contained in this Order.

### PART B

### Description of site of new path

A new length of path running from point A Grid Ref SU 60883 88842 in a generally southern direction for 19m to point F Grid Ref SU 60882 88823 continuing in a generally south westerly direction for 10m to point G Grid Ref SU 60873 88818 thence in a southerly direction for 70m to Pont E Grid Ref SU 60866 88761 via Points H Grid Ref SU 60866 88811, I Grid Ref SU 60867 88798 and J Grid Ref SU 60863 88772 and having a width of 1.85 metres including on the bridge as shown on the map contained in this Order.

## PART C

### Limitations and conditions

The swing bridge forming part of the diverted route (as indicated on the attached map between Point F [Grid Ref SU 60882 88823] and Point G [Grid Ref SU 60873 88818] )shall:

1) not be opened at any time SAVE when boats access or exit the boathouse PROVIDED ALWAYS that the period of time that the swing bridge shall be permitted to remain open is strictly limited to the actual time required for each boat to access or exit the said boathouse

and

2) the swing bridge shall remain accessible and usable by members of the public at all other times.
