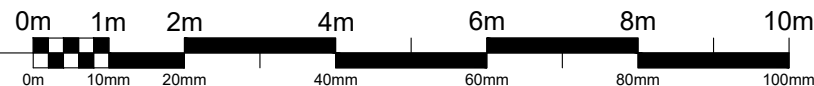


East Elevation
