For example Historic England wanted the site deleted from the Plan but are under the impression (from a section of the draft Masterplan) that the Listed Buildings at Wick would be surrounded by a green area, thus protecting their setting. However Plan TTP6 shows that there is a plan for a bus route down through Wick to connect with Barton – the only link possible but then again this may not be achievable.

I have highlighted this along with other issues in some of my other emails which I have also asked the Planning Department to be published in the Additional Correspondence about the Local Plan for the Cabinet Papers.

I am not sure how Inspector Bore didn't pick up on some of these things.

Thank you for your message below. Yes please I would very much like all these emails to be published in a pack of Additional Correspondence about the Local Plan for the Cabinet Papers.

I have received a separate message from your department directing me to the examination library - NAT14 Ecological Assessment of Sydlings Copse and College Pond SSSI.pdf

However the Nat 14 Ecological Assessment carried out by AECOM related only to the SSSI which is adjacent to the Strat 13 site but is not a part of it. That survey made no mention of the wildlife that is known to inhabit the SSSI (apart from seeing deer) and only concentrated on habitats and biological plant species associated with the SSSI as well as hydrology.

The wildlife that is known to inhabit the SSSI is recorded on the BBOWT website and will not be confined to the SSSI itself but will require surrounding fields to hunt and forage for food. The Strat 13 Land North of Bayswater Brook site stretches from near the Marston flyover in the west, stretching eastwards as far as the Bayswater Road and also includes the Bayswater field next to Sandhills on the eastern side of Bayswater Road.

As mentioned in my email of 4<sup>th</sup> inst. someone who helped survey this area as part of the BTO Bird Atlas 2007-2011 has advised us that "it is an area of environmental diversity, rich in birds, butterflies and other animals" and added that it must be preserved and protected from this desecration.

It is shocking that the Strat 13 site can be considered to be sound when there has been no survey or impact assessment on the wildlife within any part of it or the SSSI.

I am unable to find an Ecological survey of the whole of the Strat. 13 Land North of Bayswater Brook site and am wondering whether Thames Valley Environmental Records were contacted to determine the impact on this site.

Someone who helped survey this area as part of the BTO Bird Atlas 2007-2011 has said "It is an area of environmental diversity, rich in birds, butterflies and other animals. It must be preserved and protected from this desecration."

I know that AECOM undertook a very brief visit to the SSSI in February 2019 but I am unable to find any further information, particularly with regard to wildlife across the whole site. There is talk of creating NEW parkland etc, but that is equally as bad as house building in terms of displacing wildlife and destroying existing habitat needed for foraging and hunting.
