

Application for the Review of a Premises Licence under the Licensing Act 2003 –

Premises Licence Number 7641:-Latinos T/A Diamonds and Pearls and Speak Easy, Greys Road Car Park, Market Place, Henley

Recommendation(s)

- 1. That the Panel consider the application for review of this licence, and
- 2. Having heard all the evidence submitted by the various parties at the hearing, taken into account the Secretary of State's Guidance issued under Section 182

Licensing Act 2003, and the council's Statement of Licensing Policy determine if based on this that any or all of the licensing objectives have been undermined, and

3. If the Panel conclude that any or all of the licensing objectives have been undermined then they are recommended to consider what measures are necessary and proportionate in order to ensure that those licensing objectives are promoted.

Purpose of Report

1. To present the facts and relevant representations received in respect of an application by Thames Valley Police, for a review of the premises licence for Latinos T/A Diamonds and Pearls and Speak Easy, Greys Road Car Park, Market Place Henley, under Section 51 of the Licensing Act 2003 to the Licensing Acts Panel in order that the Panel can determine the application.

Strategic Objectives

2. The relevant objectives are those of "helping people to feel safe and secure" and "managing our business effectively". The relevant corporate priorities are those of "provide value for money services that meet the needs of our residents and service users" and "maintain low levels of fear of crime and anti-social behaviour".

Background

3.1 The Licensing Act 2003 ('the Act') has established a single integrated scheme for licensing premises which are used for the supply of alcohol, regulated entertainment, late night refreshment or permission to carry on some or all of these activities. In the Act these activities are referred to collectively as the 'licensable activities'.

Any assessment of licensable activities must consider and promote the following four statutory objectives:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance and
- The prevention of children from harm

- 3.2 When a valid application is received for the review of a premises licence and the review has not been withdrawn the matter will be referred to a Licensing Acts Panel to determine the application.
- 3.3 An application was received from Thames Valley Police on 3 March 2011 under Section 51 of the Licensing Act 2003 for a review of the Premises Licence **No. 7641** in respect of Latinos T/A Diamonds and Pearls/ Speak Easy, Greys Road Car Park, Market Place, Henley on Thames, RG9 2AA.

The grounds for the review are:-

Thames Valley Police are calling for review of this licence due to the premise breaching conditions and not upholding the crime and disorder objective of the 2003 Licensing Act.

The number and nature of incidents that have occurred at the premise have greatly increased over the last year. There is great concern that these incidents are increasingly involving persons who are affliated with or working for the premise.

Upon a licensing check at the premise there were several licensing conditions that are attached to the premise licence that are not being adhered to.

A copy of the review application together with the supporting documentation from Thames Valley Police is attached at **Appendix 1**.

South Oxfordshire District Council as the licensing authority were responsible for placing the necessary signs on the premises and these were put up on Friday 3 March 2011 inviting comments on the review application by 31 March 2011. A copy of the "blue notice" is attached at **Appendix 2**. The review has been called for in respect of the crime and disorder licensing objective. Thames Valley Police confirmed that copies of the review documentation were also served on the responsible authorities and premises licence holder.

4. A copy of the current Premises Licence 7641 is attached at Appendix 3 for information. This licence was first granted on 16 January 2009 to the current premises licence holder. A variation of the licence was granted on 10 June 2009 and is the licence that is currently in force. The Designated Premises Supervisor (DPS) is Mr Carmelo Borg and he has been the DPS since 22 January 2009.

There have been a number of problems over a period of time with the running of the premises and the Licensing Authority has on file correspondence between Thames Valley Police and the licence holder

outlining breaches of conditions and seeking improvements in the running of the premises. Other departments within the council have dealings with the premises from a regulatory perspective but on matters that are not of direct relevance to the licensing objectives. In respect of matters that are dealt with by Environmental Health that do relate to the licensing objectives no matters of concern have been raised. The licensing authority has conducted a number of inspections at various times both when the premises has been open and when it has been closed and these inspections have been conducted both by officers of the licensing authority on their own and in the company of officers from Thames Valley Police. During these inspections matters requiring attention have been brought verbally to the attention of the DPS and premises licence holder.

The licensing authority has received a number of letters in respect of the premises relating to the regulated entertainment of an adult nature at the premises. However the letters relate to matters outside of the council's powers under the Licensing Act 2003 and will be dealt with if and when any application under the provisions of Local Government (Miscellaneous Provisions) Act 1982 relating to Sexual Entertainment Venue Licences is received.

In respect of crime and disorder issues these have in the main been raised by and dealt with by Thames Valley Police.

- 3.5 Environmental Protection, Health and Safety and Planning in their capacity as Responsible Authorities have raised no comments on the review process either in support of it or against it.
- 3.6 Henley Town Council in their capacity as an organisation representing residents in the area has commented on the review and their letter of representation is attached at **Appendix 4**.
- 3.7 Four other letters of representation have been received and these are attached as **Appendices 5-8**. The issues raised that are of relevance to the review relate to the crime and order objective and the protection of children from harm objective. The letters of representation also refer to other matters that are not of relevance to this review.

4. Options

- 4.1 In determining an application for the review of a premises licence the authority must give weight to:
 - Representations received from Responsible Authorities
 - The Secretary of State's Guidance Issued under Section 182 of the Licensing Act 2003
 - The Statement of Licensing Policy
 - The steps necessary to promote the Licensing Objectives

- 4.2 The Panel are reminded that any decision they consider has to be proportional to only do that which it considers necessary to promote those licensing objectives that may be considered to have been undermined.
- 4.3 In view of the above, the Panel is requested to consider the application for a review of the premises licence and decide whether:
 - o Take no action, or
 - Issue a warning to the premises licence holder, or
 - Suspend the licence for a period not exceeding 3 months, or
 - o Revoke the licence, or
 - Remove the DPS, and/or
 - Vary the licence by removing, some or all of the licensable activities, and/or
 - Vary the licence by amending the hours the premises can be open, and/or
 - Vary the licence by amending the hours during which any of the licensable activities can be provided, and/or
 - Vary the licence by attaching additional conditions to the licence

5. Financial Implications

5.1 Should the applicant or any party aggrieved by the decision wish to appeal against the decision of the Council, they may do so to the Magistrates' Court. The council would incur costs should this occur, although the court may decide to award costs if the council's decision is upheld.

6. Legal Implications

- 6.1 The Human Rights Act 1998 requires public bodies to ensure everything they do is compatible with Convention Rights and makes it unlawful for a public authority to act incompatibly with those Rights. When determining applications for the review of an existing licence the panel will be aware of Human Rights considerations, specifically Part 1, Article 6, right to a fair trial and Part 2, Article 1, peaceful enjoyment of possessions (a licence is deemed to be a possession).
- 6.2 The hearing of all applications is subject to the principles of natural justice.
- 6.3 Section 17 of the Crime and Disorder Act 1998 states, 'without prejudice to any other obligation imposed on it, it shall be the duty of each authority to exercise its various functions with due regard to the likely effect of those functions and the need to do all that it reasonably can to prevent crime and disorder in its area.'

6.4 Under Schedule 5 part 1 of the Licensing Act 2003 any person aggrieved by the decision in respect of the review application may appeal to a Magistrates' Court within 21 days of the date of the decision.

Conclusion

8.1 This report provides information submitted by the applicant for the review, Henley Town Council and other interested parties. The panel should determine this application with a view to promoting the relevant Licensing Objectives which are 'the prevention of crime and disorder' and 'the protection of children from harm' and have regard to the relevant provisions of the Act, Guidance and Policy.

- 2. The Panel should, having heard all the evidence submitted by the various parties at the hearing, taken into account the Secretary of State's Guidance issued under Section 182 Licensing Act 2003, and the council's Statement of Licensing Policy determine if based on this that any or all of the licensing objectives have been undermined.
- 3. If the Panel conclude that any or all of the licensing objectives have been undermined then they should consider what measures are necessary and proportionate in order to ensure that those licensing objectives are promoted. The options available for the panel to consider are set out at paragraph 4.3 above.


