#### 1. Introduction

The purpose of this document is to ensure that our Premises are a safe environment for our Guests and Staff. We aim to achieve this by adhering to the policies contained within this document and by continuing to work closely with the Thames Valley Police and South Oxfordshire's Licensing Authority.

Carmello Borg is the overall manager of the Premises and the Designated Premises Supervisor.

This document will be reviewed on an annual basis with regular consultation with Thames Valley Police.

#### 2. CCTV

The provision of CCTV cameras will be used as a means of deterring and detecting any crime and disorder that takes place within or immediately outside Latino's / Diamonds & Pearls.

A digital CCTV system has been installed and in accordance with our Premises Licence the CCTV:-

- will cover all areas accessible by the public (except toilets) to include entrance/exit points
- images will be retained for a minimum of 31 days and supplied to the police or the Licensing Authority upon request

#### 3. SIA - Door Security

The Premises will employ a reputable security company to carry out all security functions at the Premises.

All security personnel will be registered with Security Industry Authority and will be familiar with working with Nightclub Premises.

In accordance with our Premises Licence conditions a minimum of 1 member of SIA door security staff for every 100 guests will be present at the Premises; with a minimum of 2 door security staff present at all times the premises is open to the public.

The Security team will be responsible for implementing the policies listed below.

#### 4. Admission

- a. There will be no admission of individuals that are:
  - banned
  - displaying drunk/disorderly behaviour;
  - wearing hooded tops; baseball caps and/or sportswear
  - in possession of drinks contained in bottles or glasses whether open or sealed
  - found in possession of or suspected of carrying illegal drugs or offensive weapons
- b. Maximum Capacity SIA door staff will control the admission of guests to ensure that the maximum permitted numbers (Currently 350 persons including staff) are not exceeded.

#### 5. Queue Policy

- a. A system of queuing outside the premises will be controlled and supervised by SIA Door Supervisors.
- b. SIA Door Supervisors will monitor the queue and remind customers to keep noise to a minimum to reduce disturbance to neighbouring Premises.
- c. To keep disturbance to local residents to a minimum customers will only be expected to queue if:-
  - the Premises is at maximum occupancy; and/or
  - the Door Supervisors are carrying out routine security checks; and/or

- there are large group admissions and entry needs to be staggered
- d. SIA Door Supervisors will refuse admission to persons who appear to be intoxicated.
- e. Any persistently rowdy behaviour will be met with refused entry

#### 6. Search Policy

- a. The Security team will monitor and regularly patrol queues
- b. SIA Door Supervisors will carry out routine security checks/searches for alcohol; illegal drugs and weapons:-
  - If a person is found to be carrying alcohol they will be refused entry.
  - In the case of illegal drugs or weapons the Police will be called and contact
    details of the person carrying the items will be noted in the Refusals register
    and entry to the Premises will not be permitted at any future date.
  - A search Policy for staff is also in operation; any staff found to be possession of, or under the influence of illegal drugs will be dismissed without notice.

#### 7. Dispersal

- a. The premises will establish a direct phone link to a licensed taxi company
- b. Notices to request patrons to leave quietly will be displayed
- c. The volume of music towards the end of the evening will be reduced and where appropriate playing quieter music as the evening winds down/terminal hour approaches.
- d. Security staff will ban people from returning if they regularly leave in a noisy fashion
- e. No person will be allowed to remove alcohol; glass or bottles from the premises

#### 8. Smoking Policy

The Security team will ensure that those persons permitted to leave to visit the designated smoking area are not causing a disturbance and are given a fixed 10 minute time limit to re-enter the Premises.

9. Age related schemes

No persons under the age of 18 will be permitted entry to the Premises unless for a pre

arranged Under 18's function of which prior agreement will be sought from Thames

Valley Police.

The Premises operates an over 25's policy but allows over 21's at the Management's

discretion.

10. General Security measures

1. The consumption of alcohol to take place on the Premises only. Guests will not

be permitted to take drinks outside.

2. Both male and female toilets will be checked by a member of staff at least once

every 60 minutes.

3. The Premises will not engage in irresponsible drinks promotions that encourage

binge drinking.

4. All incidents or crime and disorder will be recorded in an "Incident Log Book"

which will also contain the name; badge number; and start time of SIA door

staff.
