We write with regard to the application for licensable activities as made by The Quince Tree, Stonor Arms Hotel, Stonor.

We are deeply concerned about those activities, which, if a licence were to be granted, would take place outdoors; for example, "Live Music (E)", "Recorded Music (F)", "Dance Performance (G)" and "Dancing Facilities (J)", as referenced above.

Whilst we have no objection to indoor activities being permitted (including music and dancing), we most *strongly object* to any such activities being permitted outdoors and which, in our estimation, cannot but fail to cause a Public Nuisance.

We note that one of the conditions of the Planning Permission granted on 28 August 2009 (PO8/E1278) was that "no amplified/live music shall be played in the Restaurant Garden Terrace. Reason: to protect the occupants of nearby residential properties from loss of amenity due to noise disturbance and in accordance with Policies G2 and EP2 of the South Oxfordshire Local Plan 2011."

Whilst this condition refers to the Restaurant Garden Terrace, we are of the opinion that music played *anywhere* within the boundary of the Quince Tree, Stonor Arms Hotel would be audible well beyond the adjoining residential properties. Surely, this would wholly contradict the intention of the voluntary condition in the application that: "noise from the regulated entertainment shall not be clearly audible at the boundary of the nearest residential property".


