Proposal to add White Lane into 7 property addresses in Bix where a street name plate exists but White Lane has not been recognised by Royal Mail

Recommendation

To review the evidence regarding the proposal to add White Lane into 5 residential addresses and 2 commercial addresses in Bix, and to decide whether the street should be formally named as originally intended

Purpose of Report

To present the evidence to the panel to enable the panel to make a decision on the recommendation in the best interests of residents affected

Background

The street naming and numbering function is to ensure properties are given either a number as part of a consecutive numbering system or a house name that is not duplicated within the vicinity, and a street name. A street name plate and a prominently displayed house number or name is for the safety of residents as they provide a visual, on the ground guidance for the drivers of the emergency services.

The district council is the street naming and numbering authority and is responsible for creating and changing the first two lines of all addresses as required under

Sections 13 and 14 of the Oxfordshire Act 1985. Royal Mail is responsible for applying the remainder of the address. The district council is also responsible for displaying street name plates at the extents of all streets but is only permitted to do so when a street has been named under the relevant enactment. This would also include the previous Act, Section 64 of the Towns Improvements Act 1847.

Some rural settlements are without the benefit of street names and may have a few unnamed streets running in different directions within the settlement. The settlement of Preston Crowmarsh has one main unnamed street running through it and it's numbered 1 to 114 Preston Crowmarsh, which provides a consecutive sequence. But where a settlement has more than one unnamed street and the properties are all named it's more difficult for the emergency services to find the correct property.

In late 1998 Bix and Assendon Parish Council made a request to the district council to officially name White Lane (See Letter Appendix 1). The district council duly proposed the naming and carried out a 28-day consultation as required by Section 13 of the Oxfordshire Act 1985 (See Public Notice and Plan Appendix 2). Three objections were received (See Objections Appendix 3), and the matter was referred to the Community Services Committee on 18 March 1999. It would appear the committee found in favour of the district council's proposal as a letter confirming the naming was sent to Bix and Assendon Parish Council on 19 March 1999 (See Letter Appendix 4). A street name plate was subsequently installed at the western extent of White Lane. Unfortunately, White Lane was never added to Royal Mail's postal addresses, which was only noticed by the district council several years later; but too late to just add the name without carrying out another consultation.

In January 2023 a resident of one of the properties in White Lane made a telephone request to the district council to have White Lane added to their postal address. However, Royal Mail would require all the addresses with the same post code to have White Lane included. Therefore, it was necessary to repeat the 28-day consultation which was carried out between the 12 of January and 10 of February 2023. (See Covering Letter, Public Notice and Plan Appendix 5). The consultation resulted in two objections which were received from the same household (See Objections Appendix 6).

8. Royal Mail addresses are sold on a commercial basis and appear on all manner of web site address dropdowns. There is also an increasing number of organisations referring to Royal Mail as the benchmark for official addresses and post codes. It's therefore crucial that the district council and Royal Mail addresses are in step. Street name plates should only be present where the street name is part of any corresponding address and may cause confusion if the expected street name is missing. To ensure that there is a consistent position it is considered appropriate that either the street name is added to the seven addresses to accord with the street name plate, or the addresses are left as they are, and the street name plate is removed.

Thank you for your letter of 15th June 98 addressed to and passed to me for action.

As you note, the response to the proposed names put forward by the Parish Council was mixed in the extreme. However, the Council is firm in its resolve to aleviate the problems faced by many entering the village for the first time wishing to locate a house.

As you will appreciate, it would be impossible to satisfy the wishes of all responders since many are in conflict, and at the meeting of the Parish Council on 28th Sept.98 it was agreed that recommendations would be made such that the need for identification would be met combining simplicity and economy and bearing in mind certain objections.

In the case of BROADPLAT & BIX BOTTOM it was felt that these were adequately signed and that NO ACTION be taken.

<u>OLL BIX ROAD</u> be signed adjacent ot to the Church only. This reflects objections of Lower Assendon residents to signing.

<u>RECTORY LANE</u> to be signed from Bix Crossroads running to join the acknowledged Rectory Lane which runs from 'Bix Field' to the Bix Bottom triangle. The use of this name is supported by the O.S.Map of 1880 which shows the new church of St.James with (Rectory) alongside.

I note your comments regarding WHITE LANE, however, it is the age 5 /view



view of the Council thatthere is no case for the lane running along the common field to be named Rectory Lane simply because one house is named The Old Rectory, which in itself is a misnomer since it was the New Rectory. Our recommendation is that WHITE LANE which runs from Middle Assendon to 'PEPPERS' should be extended to the residence 'BIX FIELD'

The foregoing does meet the requirement of assisting in the identification of properties whils keeping the number of signs in the villages to a minimum.



RE: Official naming of White Lane, Bix, HENLEY-ON-THAMES RG9 6BP

I am writing to inform you that the district council has been asked to repeat the process of officially naming White Lane. I believe the process was carried out several decades ago, but White Lane was never added by Royal Mail to the property addresses of those properties accessed from White Lane.

In future the extents of White Lane in Bix will run from between the properties known as Bix Field and Westgate House to just past the property known as Peppers. The reason for this is that Bix Field has a different post code and therefore would not be able to have White Lane added to their address. The visible solution to this would be to change the existing street name plate for White Lane at the junction with Rectory Lane to read:

LEADING TO WHITE LANE

And then add another sign for White Lane at the new start of the named street. I have written to the owner/occupier of Bix Field to explain the district council's proposal. Should the owner/occupier choose to be included in White Lane then the street name plates wouldn't change unless we received a request to update them.

To name a street which is officially unnamed the district council must carry out a 28day public consultation as required by Section 13 of the Oxfordshire Act 1985. This involves displaying a public notice at the extents of the section of street to be named. The notice must state the name of the section of street and how those owner/occupiers affected may object. A copy of the notice is enclosed.

If White Lane becomes the official name of the street your property is accessed from your address will be known as:


