	2) Unfortunately, there was insufficient budget to give all the high priority projects the full amounts requested, so they were each allocated 87 per cent of the requested amounts (with the exception of Thame Town Council, who were awarded 78.62 per cent of their request). This meant the cricket club had an unexpected funding gap of £3,811.		
	3) The cricket club renegotiated with their supplier to reduce the cost by this £3,811 shortfall. However, the approved award was both capped to a maximum amount and fixed at a percentage of the total project cost. By reducing the project cost the applicant therefore requires a greater percentage of the project cost to receive the financial sum previously approved.		
	Were we to now apply the maximum percentage restriction, there would again be a shortfall for the applicant.
