Decision	To accept the award of £100,000 revenue funding for Didcot Garden Town from the Ministry of Housing, Communities and Local Government (MHCLG), and; in accordance with the council's Financial Procedure Rules in relation to receiving government grant outside of the usual budget setting cycle for which no budget exists, to request the chief finance officer, in consultation with the leader of the council and the chief executive, to use the grant to increase the Didcot Garden Town revenue budget (AH03).			
Reasons for decision	 Accepting the £100,000 revenue funding will support delivery of Didcot Garden Town as follows: advancing the strategies of connected green space, cultural communities, inspired green living and a network of public transportation, cycling and walking links to key employers at Culham Science Centre, Harwell Campus and Milton Park; and 			
	 salaries, consultant expenses and costs to implement the Delivery Plan. Accepting the £100,000 capacity funding and moving ahead with projects may attract further funding from the government for capital funding to implement the Didcot Garden Town Delivery Plan strategies. South Oxfordshire will act on behalf of South and Vale as the accountable body for the revenue funding, which was deposited into their bank account by Homes England. The project is a joint project and funding will be managed in a way that benefits the Didcot Garden Town, which lies within both South and Vale. 			
Alternative options	The council could choose not to accept the funding. Under

rejected	this scenario, it is unlikely that Homes England would offer the council the opportunity to bid for annual funding under the Garden Communities programme. Without this funding the continuation of the Didcot Garden Town work would need to be funded from elsewhere.					
Legal implications	The funding has been granted under S31 of the Local Government Act 2003 and it is to support South Oxfordshire District Council towards expenditure lawfully incurred or to be incurred. Homes England (MHCLG) will monitor how the funding has been used to progress the project through regular contact with South Oxfordshire District Council officers.					
Financial implications	South Oxfordshire District Council's Constitution, states that receipt of a government grant, even one over £75,000, is excluded from the definition of a key decision. The receipt has been placed in an earmarked reserve for Didcot Garden Town. Acceptance of the receipt will not commit the council to any other additional unbudgeted expenditure over and above the £100,000 receipt.
