Introduction

The South Oxfordshire District Council Climate Action Plan (CAP) 2022-24 sets out to demonstrate and deliver the council's commitment to the Corporate Plan objective of taking 'Action on the Climate Emergency' and target of becoming a carbon neutral council by 2025.

Progress on the actions and outputs in the CAP are reported quarterly, in line with the council's Corporate Performance Management Framework. This report provides a strategic overview of the climate action performance across the council for Quarter four 2023/2024 (01 January to 31 March 2024) and should be reviewed in context with the council's quarterly Corporate Plan Performance Report. The council's greenhouse gas emissions are also reported and published annually.

The CAP is one piece of a much larger picture, consisting of national, regional and local initiatives and plans, all of which influence our priorities. The CAP was designed to be a live document, where quarterly progress reporting may result in the reprioritisation or refocusing of actions by Cabinet where necessary.

Quarter context

HM Government and Net Zero

In July 2023, HM Government unveiled its third **National Adaptation Programme (NAP3)**, which set out a strategic five-year plan with aims to boost resilience and protect people, homes, businesses and the UK's cultural heritage against climate change risks such as flooding, drought and heatwaves. This quarter, the Climate Change Committee (an independent, statutory body established under the Climate Change Act 2008) produced an initial assessment of the NAP3. The committee concluded in its report that the NAP3's governance, investment and monitoring needs action and strengthening and encouraged its evolution over its five-year lifetime.

Biodiversity Net Gain (BNG) requirements came into law nationally in February, meaning developers in England will have to deliver at least ten per cent BNG when building new housing, industrial or commercial developments. BNG was introduced through The Environment Act, which received its royal assent in November 2021. BNG is however not a new concept for South Oxfordshire, where similar approaches to enhancing the wildlife value of new developments have been in effect since becoming the first authorities in the UK to successfully secure a BNG agreement in 2013. This was following the Vale of White Horse becoming the first planning authority nationally to secure an agreement to provide biodiversity net gain resulting from a development in Shrivenham - the resultant funding was used to restore an important chalk grassland site in South Oxfordshire.

Following the announcement in September 2023 of HM Government's decision to delay the ban on new diesel and petrol cars from 2030 to 2035, this quarter, **the zero-emission vehicle (ZEV) mandate** - the new pathway towards all new cars and vans being zero emission by 2035 – was made law. The ZEV mandate sets out the percentage of new zero emission cars and vans manufacturers will be required to produce each wear up to 2030, with 80% of new cars and 70% of new vans sold in Great Britain to be zero emission by 2030, increasing to 100% by 2035.



Record-breaking Temperatures

Data released this quarter confirmed that **2023 was the UK's second** warmest year on record. Across the world, each month since June 2023 has seen new temperature highs for the time of year. Scientists attribute the temperature rises to in part, the Pacific's El Niño weather event (the warming of sea surface temperature that occurs every few years, typically concentrated in the central-east equatorial Pacific), alongside in the main, human-caused climate change.

In February, the EU's Copernicus Climate Change Service revealed that the period from February 2023 to January 2024 reached 1.52 degrees Celsius of warming. This is the **first-time global warming has exceeded 1.5 degrees Celsius across an entire year**. Limiting long-term warming to 1.5 degrees Celsius above pre-industrial levels has become a key symbol of international efforts to tackle climate change.

Energy

Drax, one of the country's largest electricity generators, released figures this quarter which show **Britain's energy mix** (the combination of different energy sources used to meet a country's total energy consumption) had its **greenest year on record in 2023**, with renewable and cleaner energy replacing fossil fuels in the energy mix. Drax said fossil fuels accounted for 35 per cent of the UK's energy mix in 2023, down from 43 per cent in 2022.


The annual **Earth Hour**, led by the Worldwide Fund for Nature (WWF), was observed around the world in March. Households, along with national landmarks, switched off their lights for a set time, as part of an awareness campaign highlighting the importance of taking action to adduce carbon emissions.



Rivers

At the end of this quarter, the Environment Agency published its Event Duration Monitoring (EDM) data for 2023 showing the frequency and duration of spills from storm overflows in England. It is reported that **South Oxfordshire saw sewage from storm overflows flow into water bodies for 11,012 hours in 2023**, during 810 spills.

This quarter, the Department for Environment Food & Rural Affairs (Defra) launched a national consultation on the proposed new sites to be awarded Bathing Water Status, for the upcoming bathing season – 15 May to 30 September. The list of sites included a point on the River Thames, in Wallingford. The outcome of the consultation is expected next quarter. If a site has a designated bathing water status, bacteria harmful to human health (such as E. coli and Intestinal enterococci) are weekly monitored during the bathing season by environmental agencies and information on the water quality is displayed publicly.

The new 'climate impact assessment tool' started to be trialled by officers this quarter. The tool will help ensure the climate and environmental impact of our work is considered and embedded within our decision making. Officer feedback on use of the tool will enable it to be reviewed and updated before it becomes mandatory later in the year.

Work also continued this quarter on the net zero evidence base for the forthcoming Joint Local Plan; alongside the launch of the Joint Local Plan consultation, the Council published a report by consultants Bioregional, who are appointed to provide the net zero evidence base for the Joint Local Plan, and advice on the role and weighting of offsetting policies in the new Plan.

Additionally, the Council's Driving at Work policy was approved and published this quarter. Aspects of the Policy consider the impacts of corporate vehicles on the environment, alongside personal vehicles used for work purposes. The Policy also brings the introduction of telematics to enable monitoring of corporate vehicles, which will include idling activity with the aim of reducing idling and improving air quality.

This quarter, work continued to develop the strategic approach to our future waste services which, accounts for just over 40% of the Council's greenhouse gas emissions. A waste fleet replacement vehicle strategy was developed, which sets out a new process for the Council to follow when purchasing new vehicles. The proposed process includes assessing the condition of the current Biffa fleet, reviewing the fuel options available in the waste vehicle industry, analysing the costs and agreeing the capital budget provision as part of the budget setting cycle. The new strategy is anticipated to support decision-making, taking into account vehicle suitability alongside financial and climate implications. The next steps are for the strategy to be taken to Cabinet for approval.

Jointly, with Vale of White Horse District Council, this quarter a proposal was also submitted for Ministry of Transport funding, to carry out an initial 12-week trial of an Electric Refuse Collection Vehicle. If the application is successful, the trial would provide insight into how effective a battery powered large waste collection vehicle could be in the districts.

In February, the Air Quality Action Plan was approved by the Licensing Committee. The new plan looks to build on the successful reduction in the volume of nitrogen dioxide over the last five years. To achieve this, the plan aims to reduce traffic emissions by promoting healthier and cheaper options for short journeys, such as walking and cycling. Where vehicles are needed the councils will promote the increased use of public transport and low emission vehicles such as EVs.

KEY ACTIVITIES

The Council is committed to enhancing biodiversity on council owned land and this quarter, officers updated senior managers on the outcome of the 2023 'Let it Bee' resident's feedback consultation, alongside a review of the sites and proposals for the 2024 season. An additional area of 1,050m2 will be managed as meadow in 2024, to make a total of 10,250m2, allowing biodiversity to thrive by allowing wildflowers and grasses to grow and provide nectar for pollinators.

Oxfordshire's bid for its Local Electric Vehicle Infrastructure (LEVI) funding allocation was approved this quarter, with £3.6 million allocated to the county. Officers from South Oxfordshire District Council have been working with Oxfordshire council partners on the plans for delivering the infrastructure project. It is planned that where feasible, most of the new public EV chargers will be installed in off-street parking locations such as council car parks, building on the success of the Park and Charge project.

The Council was notified of a successful bid this quarter, from the Public Sector Decarbonisation Scheme (PSDS). £1.49 million was awarded for the decarbonisation of Didcot Wave Leisure Centre and Park Sports Centre in Wheatley. Works from this funding will include removing fossil fuel heating systems and installing air source heat pumps. The council was also notified of a successful bid to Sport England's support fund for swimming pools, for Thame Leisure Centre. This funding is for installation of PV solar panels.

At quarter four, project delivery at Cornerstone Arts Centre, Didcot, continued, with preparations being undertaken for the procurement of a main contractor. These decarbonisation works will continue over into the next financial year.

n line with the council's aims to work with communities, businesses, the voluntary sector and residents to address the climate emergency, this quarter we continued to promote retrofitting and energy saving for organisations and residents, sharing the newly created leaflet and council webpage on this subject.

Residents were also invited to contribute to the Oxfordshire Local Nature Recovery Strategy, of which the council is a partner. Businesses were encouraged to respond to the Economic Development survey in conjunction with Oxford Brookes University, which aimed to discover how best to help local businesses on their climate journey.

This quarter the council also launched a climate survey for town and parish councils, asking how the council can support local decarbonisation and nature recovery initiatives and raise awareness of the services currently offered.

The CAP aims to build on the council's partnership work as key to achieving out climate emergency targets. Awards were made this quarter from the council's Rural England Prosperity Fund and UK Shared Prosperity Fund and went towards supporting a range of climate action projects including retrofitting community buildings, renewable energy schemes, EV charging infrastructure and nature recovery projects.

Economic Development continued to actively participate in OxLEP's Net Zero Joint Oxfordshire Business Support group this quarter, contributing ideas to the LEPs planned single entry point website for net-zero support and reviewing a potential accreditation scheme for eco-friendly tourism businesses.

Work has continued this quarter on agreeing an Oxfordshire wide approach to Local Area Energy Planning. A Local Area Energy Plan will set out the actions needed to transition to a netzero energy system, including addressing grid capacity issues. In quarter four, officers have worked closely with neighbouring authorities to establish the governance structures, process and scope for our Local Area Energy Plans.


