Decision	To: Allow the South Oxfordshire Local Plan 2031 Issues and Scope document, and accompanying Local Plan 2031 Sustainability Appraisal Scoping Report, to be published for a period of six weeks from 11 June 2014 to 23 July 2014 for public and relevant stakeholder comment.		
Reasons for decision	To launch and progress initial work on the Local Plan 2031; to gather local opinion and that of other relevant stakeholders on matters such as the scale and distribution of additional development, and future planning policies for development. This will inform the preparation of the plan, towards further rounds of consultation and the eventual examination and then adoption by the Council. The Local Plan will then become part of the development plan to be used in the determination of planning applications.
