Decision	That the North Wessex Downs AONB Management Plan (2014-2019) is adopted
Reasons for decision	<p>The preparation of a Management Plan for AONB's is a statutory requirement of the Countryside and Rights of Way Act (CRoW) 2000. It is intended to guide the activities of all who live and work in the AONB to help conserve and enhance the area's natural beauty. The plan for the North Wessex Downs is prepared on behalf of this council and the other constituent local authorities by the North Wessex Downs Council of Partners. We have a representative on the Council of Partners and currently provide funding for their activities along with the other constituent local authorities and Natural England.</p> <p>The management plan sets out a vision for the North Wessex Downs and is split into seven key themes designed to better focus the delivery of objectives. The themes are Landscape, Land Management, Biodiversity, Natural Resources, Historic Environment, Development, Communities and Leisure and Tourism.</p> <p>Each of the key themes is evaluated and described in detail and the key issues affecting them are drawn out. The key issues are used to form objectives which are supported by a number of policies.</p> <p>The plan policies are designed to be delivered by a wide range of stakeholders and partners in the AONB. The core AONB unit co-ordinates the monitoring and delivery of the plan policies and are directly responsible for the delivery of</p>

	<p>certain work areas.</p> <p>The council was consulted on the draft plan and a consultation event was held in the council offices on the 16th September 2013. In addition the council provided a written response to the draft plan.</p> <p>Following feed-back from consultations with Ward Members at the Vale of White Horse with regard to the Harwell Campus p.47 of the plan has been updated from:</p> <p><i>Significant employment sites do exist within the area, for example the Harwell Campus as part of Science Vale UK. That includes the Diamond Light Source, the UK national synchrotron facility. Opportunities exist within these sites for redevelopment and expansion without the need for new greenfield sites.</i></p> <p>To;</p> <p><i>Significant employment areas exist within the area, for example the Harwell Campus which includes the UK national synchrotron facility. This is part of 'Science Vale' in Oxfordshire, which has a national profile as a centre for science and innovation, in particular space technology. As a large previously developed area, partly designated as Enterprise Zone, opportunities exist here for redevelopment and intensification of the site.</i></p> <p>In addition, the plan has been further amended to align with the requirements of the National Planning Policy Framework in relation to housing growth within the Science Vale area. The paragraph titled 'Built Environment and New Housing' on page 50 has been amended to the following (amendment shown in red):</p> <p><i>In general, strategic levels of new housing within the area should be avoided except in exceptional circumstances, in line with the recommendations of the NPPF.</i></p> <p>These changes have been accepted by the relevant Ward Member.</p>
<p>Alternative options rejected</p>	<p>None - Adoption of the revised management Plan is a statutory requirement of the CRoW Act. Failure to adopt a plan would be in breach of this requirement, be unsatisfactory to the relevant Government body Natural England and possibly hinder the conservation and enhancement of the AONB's natural beauty.</p>
<p>Legal implications</p>	<p>The preparation of a Management Plan for AONBs is a statutory requirement of the Countryside and Rights of Way Act (CRoW) 2000. We delegate the preparation of the plan to the Council of Partners but each constituent council is required to formally adopt the plan.</p>

<p>Financial implications</p>	<p>We are represented on the North Wessex Downs AONB Council of Partners and provide funding for their activities along with the other constituent local authorities and Natural England. DEFRA provides core funding with the constituent local authorities sharing responsibility for the remainder.</p> <p>The proportion of funding from each local authority corresponds to the amount of AONB land within that authority. We fall within the lowest band contributing 1 per cent of the core costs. For the period 2013 to 2014 this amounted to £4,117. For the current year 2014 to 2015 this amounts to £3,807. The fall in contributions in 2014/15 is due to a reduction in the core grant provided by DEFRA and a consequent reduction in the percentage attributable to the council.</p> <p>The adoption of the Management Plan has no implications for providing any funding additional to the annual contribution</p>
