Decision	To approve a new policy for awarding Capital Grants, which		
	is attached in appendix 1.		
Reasons for decision	To improve the existing policy to reflect the feedback received from councillors and applicants about opening more often for grants over £15,000 and simplifying the application process.		
	We are due to open the capital grant scheme for grants under £15,000 in late September 2015 and the cabinet member for grants is keen to have the new policy in place before then, so that organisations looking for grants over £15,000 can also apply.		
Alternative options rejected	Continue with the existing policy with its current restrictions such as preventing organisations from applying within two years of a grant award, even if it's for a different project and opening the over £15,000 scheme just once a year.		
Legal implications	According to the council's scheme of delegations, the cabinet member for Grants can approve changes to the Communities Capital Grant policy and procedure.		
Financial implications	None. The council agreed a budget of £1 million for capital grants at its budget-setting meeting in February 2015. The budget isn't split between the two existing schemes.		
Other implications	Delaying the approval of the policy changes will mean we can't invite applications for grants over £15,000 when we open for grants under £15,000 in September. If we spend the budget during that round of funding then we won't be able to open for another round of over £15,000 grants until next year.
